1. Identification

Leaf: Folio 7v (Corpus Christi College MS 255A, Digital Bodleian).

Dominant figure: Three large interlocking circles (green / blue / red) labelled with the persons of the Trinity and the two Testaments, plus two secondary miniature key-diagrams in the lower corners and an Alpha–Omega zone in the upper right.

Function: Reference guide / baseline key for locating prophetic lineage inside the Trinitarian-historical system.

3. Main Diagram — Three Interlocking Circles

The central figure is the classic Joachimite mapping of the Trinity onto the three statuses of history:

- **Pater** (Father) — associated with the Old Testament / first status
- **Filius** (Son) — associated with the New Testament / second status
- **Spiritus Sanctus** (Holy Spirit) — associated with the third / spiritual status

The circles interpenetrate rather than sit side-by-side, showing that the ages share substance while remaining distinct. Labels for *Vetus Testamentum* and *Novum Testamentum* sit inside the appropriate zones.

4. Alpha–Omega Zone (Upper Right)

Large **A** (Alpha) and **W / Omega** form with surrounding notes equivalent to “I am Alpha and Omega” and divine-name labels (God of Abraham, Isaac, Jacob style). This zone marks the full span of the system from origin to consummation.

5. Bottom-Left Cluster — Patriarchal Key

A miniature set of small circles containing the names:

- **Abraham · Isaac · Jacob**

paired with abbreviated person-labels (*Pater / Filius / Spiritus Sanctus*). This is the **human root of the prophetic and covenantal lineage**. Everything that follows in the historical spiral grows from this triad. The cluster sits outside the main geometric lattice, functioning as a side-key rather than part of the central engine.

Close-up confirmation (Bodleian surrogate): the red-ink names *abra · ysaac · iacob* are unambiguous.

6. Bottom-Right Cluster — Temporal Status Key

Three small interlocking rings with clear labels (confirmed by close-up):

- **Caput ante legem** — head / beginning before the Law
- **Caput sub lege** — head under the Law
- **Caput sub euangelio** — head under the Gospel

This is the classic three-stage division of history (before the Law / under the Law / under the Gospel). It is a temporal-status key, distinct from the patriarchal key on the left.

7. Function of the Page as Reference Guide

Folio 7v is not a narrative diagram. It is a **baseline reference guide** that supplies the fixed coordinates needed to track prophetic lineage:

- Main circles → the divine structure the ages move under
- Bottom-left cluster → the human root of the lineage (Abraham–Isaac–Jacob)
- Bottom-right cluster → the three historical conditions the lineage passes through
- Alpha–Omega zone → the span from origin to consummation

Everything else in the book can be read against this page. It is the key for locating any later prophetic figure or generation inside the system.

8. The Historical Gap

The page gives a clean origin and a clean three-stage frame, but between the last clear medieval markers and the present there is a long gap with no continuous, publicly legible prophetic register. The chain is broken in the historical record even if the underlying logic of the page remains intact.

The diagram can still function as a reference key without being able to name the current holders of the line. It tells you *how* the lineage is structured and *where* it begins. It does not by itself supply the missing middle centuries.

9. Possible Succession Patterns

Two structural possibilities remain open under the geometry of the page:

1. **Two per era / status** — each of the three great conditions carries a pair of witnesses or prophetic voices.
2. **Two concurrent (overlapping)** — a continuous double line so the chain never drops to a single point of failure (the “two witnesses” pattern).

Folio 7v does not print the later succession rule. Both patterns remain possible. If either is correct, reconstruction proceeds by locating any secure later pair and working backward by the same interval or pairing logic until the chain reconnects to the patriarchal key on this page.

10. Status of the Reading

- Main Trinitarian structure: **secure**
- Bottom-left patriarchal key (Abraham–Isaac–Jacob): **secure** (close-up confirmed)
- Bottom-right temporal key (ante legem / sub lege / sub evangelio): **secure** (close-up confirmed)
- Function as reference guide for prophetic lineage: **high confidence**
- Exact later succession rule (two per era vs. two concurrent): **open**
